Terms of Service

PLEASE READ ALL OF THE FOLLOWING TERMS OF SERVICE BEFORE USING THIS WEBSITE

A. General Terms

1. These Terms of Service ("ToS") govern users access to and use of the LearnSQL.com website available at <http://learnsql.com> and any information, text, graphics, photos, films or other materials downloaded or appearing on the LearnSQL.com website ("WebSite") and LearnSQL.com service available in the WebSite (collectively referred to as "Service").
2. These ToS (and documents mentioned below) are the entire and exclusive agreement between Vertabelo SA and and the entity that uses the Service (the "User") regarding the Service, unless a separate agreement in writing regarding the Service was made. In the event of a discrepancy between the agreement and these ToS, the agreement shall prevail the ToS.
3. The Service is intended solely for entity and all rights are granted under these conditions only for entity, who is not consumer within the meaning of Article 22¹ civil code. If User is a consumer, please stop using the Services.
4. These Service is operated and provided by Vertabelo SA, ul. Filona 16, 02-658 Warsaw, Poland, registered in the register of entrepreneurs maintained by the District Court for the Capital City Warsaw, XIII Commercial Division of the National Court Register under the number 0000804757, NIP 5213728840. 5. Any complaints regarding the use of the Service User should report via email to the address contact@learnsql.com. Vertabelo SA will consider complaints within 14 days of receipt.

B. Using of Service

1. The WebSite can be used by viewing its content anonymously. Please read the information on the Privacy Policy [<https://learnsql.com/files/privacy-policy>].
2. The using all features of the Service require setting up and maintenance of an active User account.
3. Certain part of the Service is provided to you free of charge (e.g. creating account and looking at free of charge courses). Other part of the Service require payment before you can access them. Vertabelo SA reserves the right, in its absolute discretion, to determine which part of the Service is

free of charge or require payment. All information about payment are available on the WebSite.

4. Vertabelo SA may offer trials of paid content (or its part) of the Service for a specified period without payment or at a reduced rate (a "Trial"). Vertabelo SA reserves the right, in its absolute discretion, to determine your eligibility for a Trial, and, subject to applicable laws, to withdraw or to modify a Trial at any time without prior notice and with no liability, to the greatest extent permitted under the law.

G. User personal data

The data controller of your personal data is Vertabelo SA (Filona 16 Warsaw 02-658 Warsaw, Poland (further on Vertabelo)).

For what purpose and on what basis we process your personal data?

Your personal data will be processed for purposes related to the conclusion and performance of the contract and for Vertabelo marketing purposes. The legal basis for the processing of your personal data above goals is art. 6 par. 1 lit. b) and art. 6 par. 1 lit. f) GDPR. The legitimate interest of Vertabelo is the marketing of own products or services. Providing your personal data is not mandatory, but necessary for the implementation of the above purposes.

Vertabelo will entrust your personal data to other recipients entrusted with the processing of personal data on behalf of and for Vertabelo. In addition, Vertabelo

will share your personal data with other recipients, if such an obligation will result from the law.

Your data will be transferred to third countries and international organizations as long as they meet adequate safeguards.

How long will we process your data?

Your personal data will be processed during the period of cooperation and after its completion for the period provided for by law, including the provisions of the Polish Civil Code and the Polish Accounting Act.

What rights do you have?

You have the right to:

- access to your personal data and receipt of copies of personal data being processed;
- rectification of incorrect data;
- request for deletion of data (right to be forgotten) in case of circumstances provided for in art. 17 GDPR;
- requests to limit data processing in cases specified in art. 18 GDPR;
- raising objections to data processing in the cases specified in art. 21 GDPR;
- transfer of supplied data, processed in an automated manner.

If you feel that your personal data is being processed unlawfully, you can file a complaint with the supervisory body (UODO, 2 Stawki Street, Warsaw, Poland).
